7	such persons.
8	(3) Build collaborative partnerships with com-
9	munity stakeholders assisting such persons.
10	(c) Assistance.— The types of assistance author-
11	ized to be provided by VOICE to such persons impacted
12	by crimes committed by aliens described in subsection (a)
13	includes—
14	(1) the establishment and operation of a dedi-
15	cated toll-free VOICE Hotline to answer questions
16	from victims;
17	(2) local contacts to help with unique requests
18	from such persons;
19	(3) access to social service professionals able to
20	refer victims to resources and service providers;
21	(4) assistance signing up to receive automated
22	custody status information regarding an alien de-

4	(d) Report.—Not later than 180 days after the date
5	of the enactment of this Act, VOICE shall publish quar-
6	terly reports to Congress, the Secretary of Homeland Se-
7	curity, and the President of the United States studying
8	the effects of the victimization by aliens described in sub-
9	section (a) present in the United States.
